There were no public comments.


## New Business





Dear Madam Chair:

Attached are petition sheets requesting recall of the property tax rate adopted by the City of Audubon Park, composed and compiled in coordination with Election Center officials. The sheets are in no particular order, but I've numbered them for ease of reference in the event any further action is needed. By my count you should find a total of 137 signatories, comfortably exceeding the threshold of 97 prescribed for this case.

The petition committee has prescreened the lists, and found all the entries legitimate and recognizable, so if there's any difficulty in your own review with handwriting or other content, I hope you'll contact me. The one exception (p5) is a signer of good intentions, but not residing in Audubon Park and voting district H117, and thus ineligible, so we've taken the liberty of striking this entry. Please note also one case (p4) of two voters from the same household who used the same petition block, but still comprise two signatures.

The committee looks forward to your review of these results, and to next steps to move the process forward.
















